Sagardighi Kamada Kinkar Smriti Mahavidyalaya located at Sagardighi, Murshidabad, West Bengal : 742226

First Party and Second Party believe that collaboration and cooperation between themselves will promote effective use of each of their resources and provide each one of them enhanced opportunity.

Both parties, legal entities in themselves desire to sign a MoU for advancing their mutual interest.

Now therefore, in consideration of the mutual promises set forth in this MoU, the parties hereto agree as follows:

CLAUSE 1: PURPOSE & SCOPE:

The purpose of this agreement is purely academic. Both the Parties are intending to specifically undertake:

- Student enrichment programmes targeted to college students and with an aim to make their development holistic.
- Customise course curriculums and training as per the requirements of the Industry.
- Carrying out different R & D activities.
- Carrying out different awareness programmes, seminars and symposiums, workshops, specialized trainings.
- Exchange of resource persons.
- Exchange of Students.
- Implementation of different CSR and/or socio-economic and environmental projects.
- Exchange of ideas and data that are required for conducting any research projects.
- Target towards collaborative and joint works on setting up an enabling environment to spread Education and Skill development and R & D know how, expertise, best practices in the areas of R & D, Higher education, Skills Training, Train the Trainer programmes, Assessment, training of Assessors, conduct Skill Gap analysis, provide specific knowhow on skills training and technology, prior learning recognition, create assessment and certification programmes.

CLAUSE 2: MODE OF OPERATION:

Both parties will provide necessary support for effective implementation of the MoU within the institutional rules, regulations and procedures.

This MoU shall be effective from the date it is signed by both the parties.

CLAUSE 3: FINANCIAL ARRANGEMENTS:

No financial commitment is required /involved to execute the terms and conditions of the MoU.

In case of any financial assistance received as extramural grant **Hiralal Bhakat College** and/or **Sagardighi Kamada Kinkar Smriti Mahavidyalaya**, then that will be duly audited and acknowledged.

CLAUSE 4: PERIOD AND APPLICABILITY:

Unless terminated earlier as per the provision herein contained, this agreement shall be valid for an initial period of 2 (two) years from the date of signing of this MOU. Subsequently, this agreement may be renewed for such further term or terms as may be mutually agreed upon.

CLAUSE 5: TERMS AND CONDITIONS:

It is mutually understood and agreed by and between the Institutes viz. **Hiralal Bhakat College** and **Sagardighi Kamada Kinkar Smriti Mahavidyalaya**, that:

1. **Hiralal Bhakat College** and **Sagardighi Kamada Kinkar Smriti Mahavidyalaya** may mutually use and share educational facilities and may jointly guide students at various levels of academia.
2. **Hiralal Bhakat College** and **Sagardighi Kamada Kinkar Smriti Mahavidyalaya** may mutually conduct professional course/training programmes/ workshops/ seminars/conferences/field study for which certificates will be jointly issued by **Hiralal Bhakat College** and **Sagardighi Kamada Kinkar Smriti Mahavidyalaya**, to all candidates after successful completion of the same.
3. The MoU may be terminated by either party after giving a notice of **six months (180 days)** provided that this clause will be operative only if either party violates the terms of MoU or if the parties feel that no useful purpose would be served by further continuing it either due to change in circumstances or change in constituting parties.

Any divergence or differences derived from the interpretation or application of the MoU shall be resolved by arbitration between the Parties.





1. Parties to the Agreement and the Legal Framework:

The Memorandum of Understanding (MoU) is entered into on this 15th day of March 2024 towards the establishment of an Agreement by and between:

SAGARDIGHI KAMADA KINKAR SMRITI MAHAVIDYALAYA, a Government Aided College located at P.O. & P.S- Sagardighi, Dist.-Murshidabad, PIN- 742226, State: WEST BENGAL, INDIA established in 2008, remained Affiliated to the University of Kalyani, represented by its Principal and referred to as **FIRST PARTY** (which term or expression shall unless excluded by or repugnant to the contest be deemed to mean and include its successor in office representatives, administrators and assigns) for the exchange of faculties and infrastructural facilities for purely academic purpose.

AND

HIRALAL BHAKAT COLLEGE, a Government Aided Undergraduate Degree College located at Nalhati, Dist.: BIRBHUM, PIN – 731220, State: WEST BENGAL, INDIA established in 1986 referred to as **HIRALAL BHAKAT COLLEGE**, affiliated to the University of Burdwan, represented by its Principal and referred to as **SECOND PARTY** (which term or expression shall unless excluded by or repugnant to the contest be deemed to mean and include its successor in office representatives, administrators and assigns) for the exchange of faculties for purely academic purpose.

Note: Both these institutes will be hereafter referred to as Parties.

2. Vision of the Agreement:

This agreement is drawn with a view to espouse the principles, policies, visions and objectives of the National Education Policy 2020. The Policy suggests a “seamless integration and coordination across institutions and across all stages of education”. Both the institutions have the philanthropic visions to be fulfilled with regard to the MoU, which are:

- Whereas the two colleges agree upon to carry forward the ethical values and to inculcate the value of education, so that the learners can face the challenging future confidently and successfully;
- Whereas the two colleges agree upon to evolve the institute as the centres of academic excellence;
- Whereas the two colleges agree upon to construct a platform for the exploration of the potentialities of the learners to be acquainted with the global knowledge society;
- Whereas the two colleges agree upon for striving to engage the students in meaningful extension activities and community welfare works.

3. Preamble:

3.1. Understanding of Cooperation:

Whereas **SAGARDIGHI KAMADA KINKAR SMRITI MAHAVIDYALAYA AND HIRALAL BHAKAT COLLEGE** agree that cooperation in research collaborations, faculty exchange and collaborations with regard to infrastructural facilities would be mutually beneficial. The areas of cooperation may include, subject to mutual consent, any desirable and feasible activity that would further the goals of each institution with regard to academic collaboration.

Therefore, pursued by the goal of common interest **SAGARDIGHI KAMADA KINKAR SMRITI MAHAVIDYALAYA AND HIRALALBHAKAT COLLEGE** have intended to decide into the **Memorandum of Understanding (MoU)**, of which components for the cooperation are well-defined in the following Sections:

3.2. Article (i). Purpose of the Agreement:

- The broad Objectives of this agreement are to promote educational and scholarly exchange, academic collaboration between the parties involved as educational partners.
- Upon the mutual consent of both the parties, academic cooperation will be carried out in, but not necessarily limited to, the following activities:

A. Faculty/Staff exchanges

- i) Both the institutions will promote the exchange of faculty for the common UO

- ii) Faculty exchange for mutual benefit of both the institutions
- iii) Collaboration in teaching, research and development, and consultancy studies in the field of mutual interest.
- iv) Exchange of academic materials and publications.
- v) Conducting lectures with the opportunity to teachers for conducting research.
- vi) Undertaking joint research projects wherever feasible
- vii) Participation in seminars, workshops, symposia and other kinds of academic discourses.
- viii) Conducting study tours and joint consultancy work wherever feasible.

A specific plan will be worked out for each activity and detailed arrangements for such collaborative work will be agreed upon

B. Other areas

- a) To exchange information and experiences on research (subject to the consideration of the researcher) and educational programmes.
- b) To exchange information on teaching, learning material and other literature relevant to their educational and research programmes.
- c) To organize seminars, faculty development programmes, workshops jointly, on topics of mutual interest and to invite each other's faculty to participate there in.
- d) To explore the provision of cultural and intellectual enrichment opportunities for staff, faculty and students of both the institutes.
- e) To use library reading room facilities for a specified period.
- f) To use Computer laboratory and I.C.T. facilities in specific cases (with prior approval of Head of the Institutions) for a limited period.

Note: SAGARDIGHI KAMADA KINKAR SMRITI MAHAVIDYALAYA AND HIRALAL BHAKAT COLLEGE agree with the detailed terms and conditions that would guide each activity as identified above and that will be identified jointly and these will be agreed upon by the two colleges. These will also include the technical description of the proposed activity and the person(s) responsible for its implementation.

3.2. Article (ii). Coordination and Execution of the Agreement:

- A Coordination Committee consisting of two Heads and two Coordinators and quite a few members from each college will steer up the joint initiative and that will periodically (once in a year) review the activities and identify new innovative areas of activities.
- The specific activities to be carried out under this Agreement will be started in corresponding specific Sub-agreements. Once such Sub-agreements are approved by the both parties that will be attached as annexes to this agreement. The specific Sub-agreements will demonstrate the Objectives, Conditions and the Way of Execution, Period of Execution and the Administrative Responsibilities of the two parties.

3.2. Article (iii). Confidentiality of the Agreement and the Protection of Intellectual Property Rights (IPR):

- The two colleges will maintain reciprocal relations and retain and respect individual confidentiality including those pertaining to the collaborative activities of both the Colleges.
- The Agreement will respect Intellectual Property Rights (IPR) and any intellectual matter developed by the collaborative efforts shall be retained by them.

3.2. Article (iv). Duration, Amendment and Expiration of the Agreement:

The Agreement will come into effect after being signed by both parties and will be established for a period of 05 (five) years. After the completion of this period, the Agreement will automatically be extended for another 05 (five) years, unless one of the Parties expresses an intention (in written form) to cancel the Agreement at least 90 (ninety) days before the expiry date. The Agreement may be amended at any time by mutual agreement in writing as an addendum. The Amendment, Termination and Expiration of the Agreement will not affect the terms of activities ongoing at the time of Notification of Amendment, Termination and Expiration, unless otherwise agreed upon between the Parties.

3.2. Article (v). Non-Exclusivity:

The Agreement is a Non-exclusive Agreement and both Parties remain free to enter into similar Agreements with other parties.
